**REQUEST FOR QUALIFICATIONS THE TOWN OF LOUISBURG SEEKS ENGINEERING FIRMS FOR PROFESSIONAL ENGINEERING SERVICES**

The Town of Louisburg seeks statements of qualifications from firms capable of providing engineering services. The Town has received funding from the NC Division of Water Infrastructure (DWI) that will be used to fund engineering and construction projects related to municipal wastewater collection and treatment. Projects will include improvements to the Water Reclamation Facility (WRF) and the Green Hill Pump Station.

**Scope of Work**

The desired services will include providing all surveying, design, permitting, bidding, construction and grant administration, and construction observation services necessary for the successful completion of the following state funded projects in accordance with the requirements of the Division of Water Infrastructure and the Town of Louisburg:

- **WRF Nos. 1 and 3 Rotor Replacements - State No. SRF-W-0014** - Project is to replace the No. 1 and No. 3 oxidation ditch rotors and drives at the Louisburg Water Reclamation Facility (WRF).

- **Green Hill Pump Station Replacement/Relocation - State No. SRP-W-0206** - Project is to replace the existing 260 GPM Green Hill Pump Station with a new 260 GPM station and relocate the new station approximately 500 feet upstream of the existing location. The project will also require approximately 460 LF of 8" gravity sewer, 20 LF of 18" gravity sewer, and 460 LF of 4" force main to reroute the sewer lines to the new pump station site.

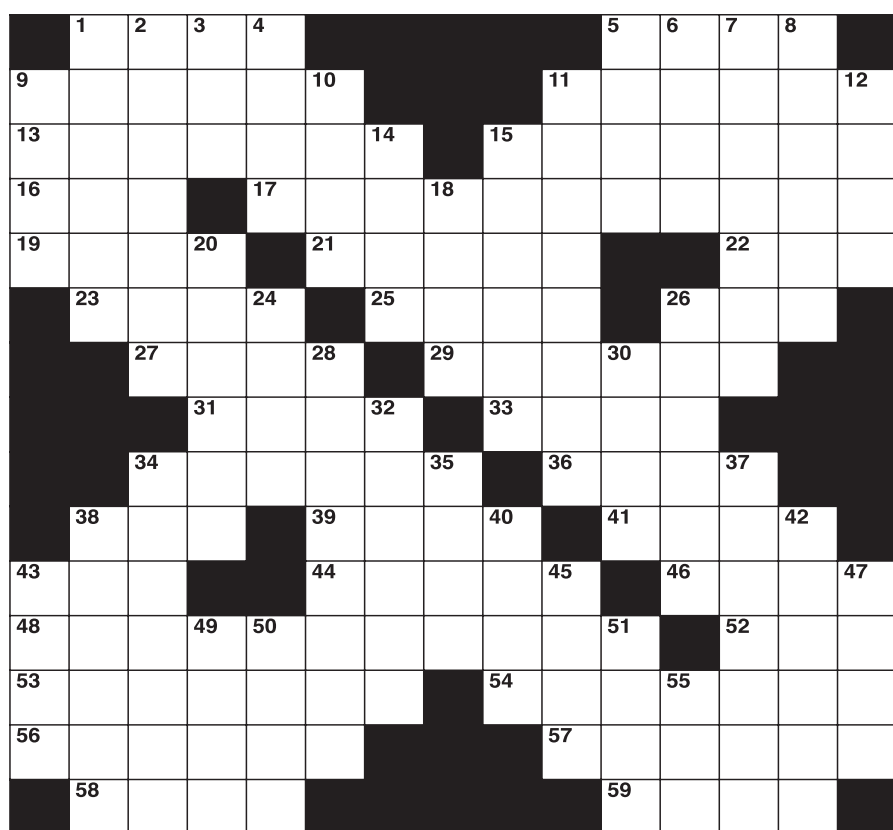
